CONSIDERATION OF CHANGE TO ILLUMINATED BOLSA AVENUE STREET NAME SIGNS AS REQUESTED BY COUNCIL MEMBER T. NUGYEN AND MAYOR PRO TEM BUI (F: 100.2)

Council Member T. Nguyen provided a report regarding the request to change two illuminated street name signs to include "Dai Lo Tran Hung Dao" under "Bolsa Avenue" located at the intersections of Bolsa Avenue and Ward Street and Bolsa Avenue and Bushard Street to match signs recently posted in the City of Westminster. The cost estimate to replace the signs is \$1,476.00, and the City of Westminster is offering to pay for the installation.

Council Member Beard wished everyone a safe and sane July 4<sup>th</sup>, and reminded everyone that the Administrative Citation for illegal fireworks is \$1,000. He asked for a verbal report on July 4<sup>th</sup> activities at the next City Council meeting scheduled July 25, 2017.

Council Member T. Nguyen thanked staff for all of their work on the budget and expressed that the City Council's goal is to promote Garden Grove and to focus on public safety.

Council Member K. Nguyen thanked staff for the work on the budget. She wished everyone a Happy July 4<sup>th</sup>, and congratulated her stepfather for getting his American citizenship.

Council Member Klopfenstein announced that the Downtown Business Association is partnering with the Garden Grove Neighborhood Association for a Meet on Main Street on July 12, 2017, at 6:45 p.m. at the Courtyard Center; Officer Brian Hatfield will be there to talk about the homeless issues and to answer questions on the Homeless Task Force.

Council Member Bui wished everyone a Happy July 4<sup>th</sup> and asked that people be considerate to their neighbors.

Mayor Jones congratulated Sonny Nguyen and his family on being recognized by the Small Business Administration and winning the 2017 Family-Owned Business of the Year Award for the 7 Leaves Café, and expressed his hopefulness that they continue to grow and keep their base in the city.

City Manager Stiles suggested that a representative from City Net attend the Meet on Main event on July 12, 2017, to discuss Homelessness. He asked that everyone encourage their neighbors to use only safe and sane fireworks. He thanked the Finance Department and City staff for their work on the budget, commenting that this is the first two year budget adopted by the City.
