11 **THIS AMENDMENT NO. 4** is effective this _____ day of _____, 2018 by and
12 between the Orange County Transportation Authority, a public corporation of the State of California
13 (hereinafter referred to as "AUTHORITY"), the City of Garden Grove (hereinafter referred to as "CITY")
14 and Korean American Senior Association of Orange County (hereinafter referred to as
15 "CONTRACTOR").

16 **RECITALS**

17 **WHEREAS**, by Agreement No. C-1-2491 dated June 27, 2011, as last changed by
18 Amendment No. 3, AUTHORITY, CITY and CONTRACTOR are entered into a contract to provide the
19 Senior Mobility Program (SMP) concerning senior transportation services for seniors receiving services
20 through CONTRACTOR; and

21 **WHEREAS**, AUTHORITY, CITY and CONTRACTOR agree to comply with the SMP Funding and
22 Policy Guidelines ("Guidelines"); and

23 **WHEREAS**, AUTHORITY, CITY and CONTRACTOR agree that CITY to be removed as a party
24 of this Agreement; and

25 **WHEREAS**, AUTHORITY, CITY and CONTRACTOR agree to replace "CONTRACTOR" where
26 it arises throughout the Agreement with "AGENCY";

1 **NOW, THEREFORE**, it is mutually understood and agreed by AUTHORITY, CITY and
2 CONTRACTOR that Agreement No. C-1-2491 is hereby amended in the following particulars only:

- 3 1. Delete "CITY" where it arises throughout the entire Agreement.
- 4 2. Replace "CONTRACTOR" with "AGENCY" throughout the entire Agreement.
- 5 3. Delete **ARTICLE 4** in its entirety.
- 6 4. Delete **ARTICLE 6** in its entirety and replace with the following:

7 **ARTICLE 6. NOTICES**
