A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GARDEN GROVE ADOPTING
A LIST OF PROJECTS FOR FISCAL YEAR 2020-21 FUNDED BY
SB1: THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017

WHEREAS, Senate Bill 1 (SB1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide;

WHEREAS, SB1 includes accountability and transparency provisions that will ensure the residents of Garden Grove are aware of the projects proposed for funding in the community and which projects have been completed each fiscal year;

WHEREAS, the City of Garden Grove must adopt a list of all projects proposed to receive fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB1 by resolution, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement;

WHEREAS, the City of Garden Grove, will receive an estimated \$2,600,000 in RMRA funding in Fiscal Year 2020-21 from SB1;

WHEREAS, this is the third year in which the City of Garden Grove is receiving SB1 funding and will enable the City of Garden Grove to continue essential road maintenance and rehabilitation projects, safety improvements, critical drainage projects, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB1;

WHEREAS, the City of Garden Grove uses a Pavement Management System to develop the SB1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the communities priorities for transportation investment;

WHEREAS, the funding from SB1 will help the City of Garden Grove construct critical drainage projects as well as maintain and rehabilitate streets, roads throughout Garden Grove this year and several similar projects into the future;

WHEREAS, the 2018 California Statewide Local Streets and Roads Needs Assessment found that the City of Garden Grove streets and roads are in good condition and this revenue will help the City of Garden Grove maintain and increase the overall quality of the road system, and over the next decade will bring the streets and roads into improved conditions; and

WHEREAS, the SB1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will have significant positive co-benefits statewide.

NOW, THEREFORE IT IS HEREBY RESOLVED, ORDERED AND FOUND by the City Council of the City of Garden Grove as follows:
