<u>PUBLIC HEARING - INTRODUCTION AND FIRST READING OF AN ORDINANCE</u> APPROVING AMENDMENT NO. A-027-2020 (F: 115-A-027-2020)

City Council consensus was frustration with the passing of State Law that limits local control on development standards for Accessory Dwelling Units (ADU's) creating density that will strain infrastructure and public safety.

Following further City Council discussion, Mayor Jones noted that the proposed Ordinance will provide the limited control over the development standards allowed under State Law.

It was moved by Mayor Pro Tem K. Nguyen, seconded by Council Member O'Neill that:

Ordinance No. 2919 entitled: An Ordinance of the City Council of the City of Garden Grove approving Code Amendment No. A-027-2020, a zoning text amendment to Title 9 of the Garden Grove Municipal Code pertaining to the regulation of accessory dwelling units and junior accessory dwelling units, be passed to second reading; and

Ordinance No. 2919 be categorically exempt from the California Environmental Quality Act pursuant to Title 14, California Code of Regulations, Section 15061(b)(3).

MATTERS FROM THE MAYOR, CITY COUNCIL MEMBERS, AND CITY MANAGER

Council Member Brietigam noted that following the amicus brief filed in support of Sheriff Don Barnes' challenge to the Court Order releasing 50 percent of inmates from Orange County jails due to COVID, the Sheriff has not been required to release additional inmates and has been allowed to keep dangerous offenders incarcerated.

Council Member Brietigam asked for support from the City Council and moved that a discussion of a Charter City feasibility study be listed on the next agenda, which was seconded by Council Member Klopfenstein.

Council Member O'Neill congratulated former Garden Grove Fire Captain, T.J. McGovern on his promotion to Division Chief for the Emergency Command Center at the Orange County Fire Authority. He commented on his frustration with State Legislators for writing into law the loosening of development standards for Accessory Dwelling Units and noted that there are Orange County cities, as well as the County of Orange discussing pushing back on the state. He noted the inherent danger in creating density with ancillary housing in terms of household fires, and he expressed his resentment for legislation that denies local control.

Council Member D. Nguyen expressed her excitement for the upcoming ground breaking for the new Sprouts store that will be developed at the former Vons Supermarket location in District 3 on Chapman Avenue west of Brookhurst Street.

Council Member Bui suggested that based on any future outcomes from Orange County cities pushing back on the state legislation on development standards for ADU's, that the City Council consider rescinding adopted ordinances. He asked that the Mayor and City Council support listing a discussion item for returning to in-person city council meetings, commenting on the difficulty of continuing virtual meetings.

Mayor Jones responded that he is not inclined to rush going back to in-person meetings as there is ongoing implementation of COVID testing, tracing, and vaccines, and he would not want to have to reverse course if it was found necessary to return to virtual meetings.

Council Member Klopfenstein noted that the City Council has an obligation to the public to be accessible; however, she does not want to rush into holding in-person meetings only to have to return to virtual meetings.

Council Member Brietigam agreed and stated that the City Council does need to get together; however, they should follow the appropriate tiers established by the health care agencies.

City Manager Stiles joined with Council Member O'Neill in congratulating T.J. McGovern on his promotion with the Orange County Fire Authority. He noted the ground breaking for the new Sprouts store announced by Council Member Diedre Nguyen, is coming up on February 24th, and will be a socially distanced event. The Vons Pavilions structure will be torn down and the developer for Sprouts is targeting the end of the year for completion. The California Department of Public Health has revised the guidance on youth sports. Garden Grove is still in the most restrictive purple tier; however the virus positivity rates are dramatically going down. The City

will follow the recommended guidelines once we have reached the Red Tier for a total of two weeks. He stated he will continue to update the City Council and the community, and noted that the bad weather in the south, mid-west and eastern states affected delivery of vaccines; however, good news is that deliveries are coming in and the County opened the Convention Center for vaccinations.
