Following the reading of the Title of Ordinance No. 2948 and City Council discussion, it was moved by Council Member O'Neill, seconded by Mayor Jones that:

Ordinance No. 2948 entitled: An Ordinance of the City Council of the City of Garden Grove amending Sections 14.12.010, 14.12.030, and 14.12.050 of Chapter 14.12 (Rates) of Title 14 (Water) of the Municipal Code relating to Water Rates and Charges, and meter failures, be adopted.

MATTERS FROM THE MAYOR, CITY COUNCIL MEMBERS, AND CITY MANAGER

In response to speakers under Oral Communications, Council Member Brietigam recommended that the City's Traffic Engineer look at ways to mitigate the traffic issues on West Street, as well as other streets that have been impacted by the installation of bike lanes, and to come up with a plan for better traffic flow. He also recommended that residents looking for the City to install street lighting to contact Public Works, and stated there is a process that begins with neighbors who want street lighting installed to submit a petition to the Public Works Department. He congratulated Council Member Cindy Tran as the new Mayor Pro Tem, he wished his wife Lisa, a Happy Belated Birthday, and wished everyone a joyous holiday season.

Council Member O'Neill wished everyone a safe and sane Merry Christmas and Happy New Year.

Mayor Pro Tem Tran thanked the City Council for their vote to appoint her as "Mayor Pro Tem" and she expressed her commitment to the residents and commented that she does take time to learn and to question staff, be familiar with city departments and has participated in a ride-along with the Police Department. Further, she thanked her friends, family, and youth groups who attended the Fight

Hunger Event, where 30,000 meals were made and donated to the Orange County Food Bank. She noted that staff came up with a way for residents to submit pictures of their exterior holiday lights to be posted on a Holiday Light Gallery on the City's website, and she encouraged residents to participate.

Council Member DoVinh credited City staff and the City Attorney on their work securing the building on the corner of Garden Grove Boulevard and Euclid Street noting this acquisition is a cause for celebration that will soon have tenants. He noted his attendance at the recent Christmas Tree Lighting Event and encouraged residents to view the event via a link posted on the City's website. He congratulated Council Member Tran on being selected as Mayor Pro Tem and stated she will serve the City well in her role. He thanked CalCities for his appointment to the Public Works, Communications, and Transportation Policy Committee. He expressed his appreciation for the meeting briefings he receives from staff, as it helps the council to make informed decisions. He recognized staff on the certification for the Housing Element, which is a legal requirement for the City to adopt a Housing Element that is a critical piece in the City's General Plan. He concluded his comments by wishing everyone happy holidays.

In response to the speaker under oral communications regarding the bike lanes, Council Member Klopfenstein noted that she has received emails from people who are happy and/or unhappy with the bike lanes. She has consulted with staff on how to mitigate the traffic issues with bike lanes and that this is a work in progress that will ultimately be resolved. In response to the speakers from District 5 regarding a need for street lighting, she stated that she will be proactive on working with staff on communicating the process for street lighting. She thanked the residents who came to tonight's meeting to voice their concerns and she expressed her appreciation for residents who come to the council meetings to address the council.

Council Member Nguyen-Penaloza stated she had the opportunity to attend the CalCities State Board of Directors meeting where local electors expressed deep concerns about an anti-local control ballot measure to be voted on this upcoming election. She asked staff to research this and whether the City will take a formal position, noting most of her colleagues on the state board have taken a nonsupportive position. She noted that there is some good news in terms of homelessness funding available from the State; however, the Governor vetoed AB 1696 a bill that would require privately owned recovery residences, i.e., Sober Living Homes to document policies and procedures, code of ethics and patient access to medications, which could become controversial. She thanked Council Member Tran for attending the CalCities Holiday event with her. She expressed her excitement and appreciation for the students who featured TikTok videos on the "Foods of Garden Grove," an idea she had when she was Mayor Pro Tem and expanded upon by City Manager Kim. She encouraged continued support for the "Foods of Garden Grove" and to keep it going and growing. She noted that she did support bike lanes and that there are many people who use the bike lanes. She

hopes for continued support for bike lanes. She wished her younger brother a happy birthday and everyone a happy holiday.

City Manager Kim noted that Thursday at 1:00 p.m. is the last day to turn in receipts to the Garden Grove Chamber of Commerce on Main Street for the Black Friday Goes Big in Garden Grove campaign. She thanked Council Member DoVinh for mentioning the Housing Element and also thanked the City Council for their support adopting the Housing Element that was three years in the making that included planning for 19,168 Regional Housing Needs Assessment units, which was a very big undertaking on the part of the Community Development team. It was a win today receiving the approval letter for the official certification of the City's Housing Element.

City Attorney Sandoval noted that there was no reportable action on the two closed session items discussed.

At 7:49 p.m., Mayor Jones adjourned the meeting. The next Regular City Council Meeting is scheduled on Tuesday, January 9, 2024, at 5:30 p.m. at the Community Meeting Center, 11300 Stanford Avenue, Garden Grove, California.
