The Community Development Director may grant minor land use permit deviations. A Director's Review may include the following:

- To allow ground-mounted equipment to be located in the setbacks on a multi-family residential project
- To allow mechanical equipment to encroach into the minimum interior dimensions of existing garages, allow one-story additions to existing, detached, nonhabitable structures which are non conforming as to required set backs.
- To allow minor changes to the requirements of any use or distance limitations of the code
- To allow minor deviations to the height and width placement of signs, the number of required parking spaces up to 10% percent, installation of garage doors on carports, deviation of landscaping requirements, fences in the setback area, or an addition to a duplex or triplex less than 50% of the original living area.

The proposed fee increase is needed to achieve cost recovery for the number of staff hours required to process a Director's Review. The current fee has not been increased in more than 10 years. Staff time for each project has also increased due to the complexity and high volume of projects being processed.

- Any new building or structure, or any addition to an existing structure or building that exceeds ten percent of the existing floor area or one thousand square feet, whichever is less
- Conversion of a single family home to any other use
- Where development standards go by individual specific plan requirements

IMPORTANT NOTICE - FEE INCREASE AS OF JULY 1, 2014

To: ALL CITIES AND COUNTIES

Strong Motion Instrumentation and Seismic Hazard Mapping

This is to inform you that legislation under SB 861 (Chapter 35, Statutes of 2014) has amended Section 2705 of the Public Resources Code to increase the seismic fee for building permits effective July 1, 2014 to provide for increased mapping of faults. The increased fee will be as follows:

\$10.00 per \$100,000 for 1-3 story residential buildings will increase to
~~\$13.00 per \$100,000~~

\$21.00 per \$100,000 for commercial and over 3-story residential buildings
will increase to \$28.00 per \$100,000.

Revised fee schedules are enclosed to assist you in computing the new fees. The 5% retention of fees collected will also be correspondingly increased. LEGISLATIVE COUNSEL'S DIGEST

SB 861, Committee on Budget and Fiscal Review. Public resources; trailer bill.

(b) There is hereby appropriated twenty million five hundred thousand dollars (\$20,500,000) to the department from the State Parks and Recreation Fund, which shall be available for encumbrance until June 30, 2016, and for liquidation until June 30, 2018, to be expended as follows:

(1) Ten million dollars (\$10,000,000) shall be available to provide for matching funds pursuant to subdivision (c).

(2) Ten million dollars (\$10,000,000) shall be available for the department to direct funds to parks that remain at risk of closure or that will keep parks open during the 2012-13 to 2015-16 fiscal years, inclusive. Priority may be given to parks subject to a donor or operating agreement or other contractual arrangement with the department.

(3) Up to five hundred thousand dollars (\$500,000) shall be available for the department to pay for ongoing audits and investigations as directed by the Joint Legislative Audit Committee, the office of the Attorney General, the Department of Finance, or other state agency.

(c) The department shall match on a dollar-for-dollar basis all financial contributions contributed by a donor pursuant to an agreement for the 2012-13 fiscal year for which the department received funds as of July 31, 2013, and for agreements entered into in the 2013-14 fiscal year. These matching funds shall be used exclusively in the park unit subject to those agreements.

(d) The department shall notify the Joint Legislative Budget Committee in writing not less than 30 days before the expenditure of funds under this section of the funding that shall be expended, the manner of the expenditure, and the recipient of the expenditure.

(e) The prohibition on the closure or proposed closure of a state park in the 2012-13 or 2013-14 fiscal year, pursuant to paragraph (a), does not limit or affect the department's authority to enter into an operating agreement, pursuant to Section 5080.42, during the 2012-13 or 2013-14 fiscal year, for purposes of the operation of the entirety of a state park during the 2012-13 or 2013-14 fiscal year.

SEC. 129. Section 2705 of the Public Resources Code is amended to read:

2705. (a) A city, county, and city and county shall collect a fee from each applicant for a building permit. Each fee shall be equal to a specific amount of the proposed building construction for which the building permit is issued as determined by the local building officials. The fee amount shall be assessed in the following way:

(1) Group R occupancies, as defined in the California Building Code (Part 2 of Title 24 of the California Code of Regulations), one to three stories in height, except hotels and motels, shall be assessed at the rate of thirteen dollars (\$13) per one hundred thousand dollars (\$100,000), with appropriate fractions thereof.

(2) All other buildings shall be assessed at the rate of twenty-eight dollars (\$28) per one hundred thousand dollars (\$100,000), with appropriate fractions thereof.

(3) The fee shall be the amount assessed under paragraph (1) or (2), depending on building type, or fifty cents (\$0.50), whichever is the higher.

(b) (1) In lieu of the requirements of subdivision (a), a city, county, and city and county may elect to include a rate of thirteen dollars (\$13) per one hundred thousand dollars (\$100,000), with appropriate fractions thereof, in its basic building permit fee for any Group R occupancy defined in paragraph (1) of subdivision (a), and a rate of twenty-eight dollars (\$28) per one hundred thousand dollars (\$100,000), with appropriate fractions thereof, for all other building types. A city, county, and city and county electing to collect the fee pursuant to this subdivision need not segregate the fees in a fund separate from any fund into which basic building permit fees are deposited.

(2) "Building," for the purpose of this chapter, is any structure built for the support, shelter, or enclosure of persons; animals, chattels, or property of any kind.

(c) (1) A city, county, and city and county may retain up to 5 percent of the total amount it collects under subdivision (a) or (b) for data utilization, for seismic education incorporating data interpretations from data of the strong-motion instrumentation program and the seismic hazards mapping program, and, in accordance with paragraph (2), for improving the preparation for damage assessment after strong seismic motion events.

(2) A city, county, and city and county may use any funds retained pursuant to this subdivision to improve the preparation for damage assessment in its jurisdiction only after it provides the Department of Conservation with information indicating to the department that data utilization and seismic education activities have been adequately funded.

(d) Funds collected pursuant to subdivisions (a) and (b), less the amount retained pursuant to subdivision (c), shall be deposited in the Strong-Motion Instrumentation and Seismic Hazards Mapping Fund, as created by Section 2699.5 to be used exclusively for purposes of this chapter, Chapter 7.5 (commencing with Section 2621), and Chapter 7.8 (commencing with Section 2690).

SEC. 130. Section 3160 of the Public Resources Code is amended to read:

3160. (a) On or before January 1, 2015, the Secretary of the Natural Resources Agency shall cause to be conducted, and completed, an independent scientific study on well stimulation treatments, including, but not limited to, hydraulic fracturing and acid well stimulation treatments. The scientific study shall evaluate the hazards and risks and potential hazards and risks that well stimulation treatments pose to natural resources and public, occupational, and environmental health and safety. The scientific study shall do all of the following:

(1) Follow the well-established standard protocols of the scientific profession, including, but not limited to, the use of recognized experts, peer review, and publication.

Justification

Currently, there is no fee listed in the master fee schedule for residential tenant improvements. The City of Garden Grove adopts the California Fire Code and all standards listed within the code. The National Fire Protection Association (NFPA) 13D STANDARD FOR THE INSTALLATION OF SPRINKLER SYSTEMS IN ONE AND TWO-FAMILY DWELLINGS AND MANUFACTURED HOMES is one of those standards listed under Chapter 9 (903.3.1.3). The requirements address automatic sprinkler system design, installation, and maintenance including numerous issues such as component listing, hydrostatic tests, sprinkler temperature ratings, design documentation, and hydraulic calculations.

The fire department has seen a significant increase in residential tenant improvements in the past two (2) years. The proposed fee is needed to achieve cost recovery for the number of staff hours during the sprinkler plan check process.

Justification:

On April 26, 2016, City council authorized staff to terminate the City's agreement with the County of Orange for animal care services and to enter into an agreement with the Orange County Human Society for animal shelter services. The agreement with OCHS does not include field or animal licensing services. Therefore, field and licensing services would be undertaken by City Staff. The proposed fees are needed to offset the cost to the City for providing an animal care program and are the same fees currently charged by the County of Orange. The fees are estimated to recover \$400,000. Attached are the detailed annual costs associated with the City's animal care program, which total \$878,360.

Impound fines are fixed and required by Sections 30804.7 and 31751.7 of the Food and Agricultural Code. The statutes set forth the amount of the fines listed above and requires that owners of nonspayed or unneutered dogs and cats be fined accordingly.
