If such conduct continues, the Mayor may order the person barred from addressing the City Council any further during that meeting.

Time Limitation: When any group of persons wishes to address the City Council on the same subject matter, the Mayor may request a spokesperson be chosen to represent the group, so as to avoid unnecessary repetition. At the City Council's discretion, a limit on the total amount of time for public comments during Oral Communications and/or a further limit on the time allotted to each speaker during Oral Communications may be set.

PUBLIC HEARING - ADOPTION OF A RESOLUTION TO AUTHORIZE THE IMPOSITION
OF LIENS ON PARCELS WITH DELINQUENT PAYMENTS FOR REFUSE COLLECTION
AND DISPOSAL SERVICE CHARGES (F: S-60.2)

Following staff's introduction, President O'Neill asked staff to clarify for the public that delinquent payments were for the billing period from the end of February 2022 and prior, to which staff confirmed in the affirmative.

Member Brietigam expressed concern with minimal delinquent balances listed on the tax roll and suggested future consideration for a threshold amount in order to determine whether a lien should be imposed.

President O'Neill requested that board members be provided an updated list of delinquent accounts.

Member Bui asked whether it is mandatory for property owners to have trash services even if they are not occupying the property. Additionally, Member Bui asked whether a resident that produces minimal amounts of trash could haul their own trash.

General Counsel Sandoval stated that trash service is required for public health and safety reasons noting that an accumulation of trash could create vermin issues for adjacent properties and affect the entire community; however, there is a provision in the Code of Regulations that allows residents that have a property that is vacant and thus not producing waste, to apply for an exemption. General Counsel Sandoval also stated that there is also a provision in the Code for residents to apply as a self-

hauler; however, the resident is required to keep detailed records in order for the City to be in compliance with state reporting requirements.

Member Bui expressed concern with liens being imposed on properties for minimal delinquent balances.

Vice President D. Nguyen asked whether account holders are contacted any other way than by mail.

Finance Director Song stated that City staff does not contact customers; Republic Services is responsible for the business relationship with customers. She also stated the City asked Republic Services to conduct more outreach notifying customers about impending lien impositions as requested by Board last year.

With no further questions from the Board, President O'Neill declared the public hearing open and asked if anyone wished to address the Board.

Speakers: Brian Malley

There being no further response from the audience, the public hearing was declared closed.

The Deputy Secretary announced that no protests were received; therefore, there was not a majority protest.

Member K. Nguyen thanked staff and Republic Services for addressing her request to have notices printed in multiple languages. She also inquired for clarification on the numbers of days past due an account must be to in order to have a lien imposed.

General Counsel Sandoval stated that state law allows liens to be imposed only if an account is 60 days or more past due.

Member Bui expressed his reluctance to approve the imposition of liens on minimal balances and inquired whether a threshold amount could be established.

Member Jones noted that Republic Services sends out multiple notices before parcels are listed on the tax roll for imposition of liens. He cautioned that establishing a threshold might create an increase of delinquent accounts with that threshold amount.

Vice President D. Nguyen stated that establishing a threshold could create more confusion and complications in managing the accounts.

Member K. Nguyen noted that procedures are currently in place that provide ample time for customers to resolve any delinquent amounts. She cautioned making any changes that could affect Republic Services' ability to collect on past due amounts.

Following closing comments, it was moved by Member Brietigam, seconded by Member Jones that:

SANITARY DISTRICT ACTION

Following staff's presentation, President O'Neill highlighted the increased services incorporated into the new contract and also highlighted the reduction in residential rates.

Member Brietigam expressed appreciation for the new alley monitoring service and expressed overall satisfaction with Republic Services' response to City needs.

Vice President D. Nguyen concurred with Member Brietigam's comments and expressed satisfaction with the community clean-up events.

Member K. Nguyen asked for clarification on the 2-year timeframe for reporting out on the Organic Waste Recycling Program compliance status.

General Counsel Sandoval stated that the program is starting mid-year and will require some time for residents to begin complying with the new Organic Waste Recycling mandate. Two years provides sufficient time to compile information to provide a substantive report.

Member K. Nguyen requested an update from Republic Services in a year that provides the overall progress or identifies issues encountered in implementing the Organic Waste Recycling program. Additionally, she requested that additional outreach be done on the Discount for Disabled and Low Income Seniors program, specifically for areas with known low income seniors like those in mobile home parks. Lastly, she expressed satisfaction with the additional services covered in the new contract and Republic Services' overall performance in providing this service.

It was moved by Member K. Nguyen, and seconded by Member Bui that:
