Council Member Klopfenstein shared that April 29th is the deadline to nominate homes for the new beatification program, Garden Grove Gems. Photos of homes and applications should be submitted online at ggcity.org/gems. Four homes will be selected to win \$100 Home Depot gift cards. Nominated homes will be featured on the Garden Grove Gems webpage from May 9 through the 13th for the community to vote for their favorites. Mayor Pro Tem D. Nguyen shared information on a recent ordinance adopted by the City of Huntington Beach that provides a mechanism for their police department to charge suspects in unlawful possession of catalytic converters, and also serves as a deterrent for potential thefts as the ordinance establishes misdemeanor charges with a fine of up to \$1,000, and/or imprisonment of up to six months. She requested Council support to list a similar ordinance for consideration at the next City Council meeting.
