AWARD A CONTRACT TO MICHAEL BAKER INTERNATIONAL FOR THE PREPARATION OF THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) COMPLIANCE DOCUMENTS FOR THE CIVIC CENTER PROJECT (F: 55-MICHAEL BAKER INTERNATIONAL)

AWARD A CONTRACT FOR THE CIVIC CENTER BRIDGE AND LANDSCAPE RENOVATION PROJECT IFB NO. S-1302-A TO RG GENERAL ENGINEERING, INC. (F: 55-RG GENERAL ENGINEERING, INC.)

Following staff introduction, Mayor Pro Tem Brietigam objected to the cost of the project and expressed that the bridge was unnecessary. Council Member DoVinh commented that the bridge design is very simple and needs to stand out in some way to suggest an iconic design that would represent the City's diversity. Following further City Council discussion, and information provided by Bob McMan, the Landscape Architect, as to the grading and clearing of and replacing existing landscaping, it was moved by Council Member DoVinh, seconded by Council Member O'Neill that:

A contract be awarded for Project IFB No. S-1302-A, Civic Center Bridge and Landscape Renovation, to RG General Engineering, Inc., in the amount of \$361,324; and

The City Manager be authorized to execute the agreement on behalf of the City, and make minor modifications as appropriate

AWARD OF CONTRACTS FOR ON-CALL PROFESSIONAL GEOTECHNICAL SERVICES FOR CAPITAL IMPROVEMENT PROJECTS TO: ASSOCIATED SOILS ENGINEERING; GMU GEOTECHNICAL; AND GEOCON WEST (F: 55-ASSOCIATED SOILS ENGINEERING) (F: 55-GMU GEOTECHNICAL) (F: 55-GEOCON WEST)

Following staff introduction, it was moved by Council Member Brietigam, seconded by Council Member O'Neill that:

Contracts be awarded for on-call professional geotechnical services for capital improvement projects to: Associated Soils Engineering; GMU Geotechnical; and Geocon West, in the amount of \$400,000 per contract;

MATTERS FROM THE MAYOR, CITY COUNCIL MEMBERS, AND CITY MANAGER

Mayor Pro Tem Brietigam pointed out that Republic Services offers bulky item pick up of up to ten items from any resident in Garden Grove, noting that there is no reason to dump unwanted items in the alleyways. He expressed the need to educate the public on their options for bulky item pick up. He noted the upcoming State of the City presided over by Mayor Jones and encouraged anyone interested in sponsoring a table to contact the Garden Grove Chamber of Commerce. He noted that for several meetings, the Waymakers have been coming to ask for support for a non-smoking policy for multi-family residential housing, he moved to list the proclamation provided by the Waymakers on the next agenda for discussion and action, which was seconded by Council Member O'Neill.

Council Member O'Neill emphasized Mayor Pro Tem Brietigam's point for opportunities for residents to have their bulky items picked up. He commented on the City Council

retreat/study session that was held on March 17th, and how he appreciated the opportunity for a robust discussion to zero in on council priorities.

Council Member Tran thanked City Manager Kim for her assistance with connecting a District 3 resident to the Be Well OC team, and she thanked Assistant City Manager Stipe for connecting a District 3 business owner to Republic Services to pick up green waste. She noted the recent Art in the Park she attended, and displayed photos from the event and the students who were recognized, and she praised Garden Grove and Los Alamitos High School students who won recent scholarships. She also recognized and praised the Garden Grove TV crew and their professionalism.

Council Member DoVinh commented on the City Council retreat that was held in the Tower of Hope at the Christ Cathedral Church. He encouraged people to tour the Cathedral, which is a proud landmark in Garden Grove. He thanked the staff for organizing a successful retreat and noted that there will be a report that will list the City Council priorities. He expressed the importance in recognizing Arab American Month in Garden Grove, and recognition to all of the diverse peoples in the City should be done. He also would like to explore adopting an ordinance for smoke-free multiunit residential properties, thanking the Waymakers for their advocacy to create smoke-free residential environments that he believes their efforts will result in growth of this movement and he would like Garden Grove to be on the forefront of this cause. He thanked Council Member Tran for sharing the photographs from recent community events, noting that as a busy person these photos are appreciated.

Council Member Klopfenstein commented on her objection to AB 742, recent legislation passed that limits the use of police canines for the purpose of arrest or crowd control, and she asked for support from council colleagues to send a letter of opposition objecting to AB 742. Rubi Garcia, founder of Aiden and Andy's Safety Group held a fantastic Autism Safety Event Day at Atlantis Park over the weekend. She noted that as Autism Awareness Day is April 2, 2023, and time is of the essence, she would like the Council support for lighting the Clock Tower blue, noting that Autism Awareness is recognized for the whole month of April; however, to mitigate the cost for lighting and patrolling for vandalism, she is recommending lighting the Clock Tower for the first week of April.

Council Member Klopfenstein moved to add an urgency item for discussion of lighting up the Clock Tower Blue, seconded by Council Member Nguyen.

Council Member Nguyen suggested that the City purchase lighting, and she asked that staff look into lighting for the upcoming Gay Pride Month in June. She suggested lighting to be installed around the palm trees next to the Clock Tower to mitigate vandalism. She noted that April is Sexual Assault Awareness Month and that as a survivor this is a personal issue for her and she appreciates council colleague support, and she noted the day of action is April 6th and she encouraged people to wear the color teal and to post on social media; she also noted the upcoming Denim Day on Wednesday, April 26th, and everyone is invited to wear their denim for a group photo in front of the Adirondack chairs at the Civic Center Park.

City Manager Kim noted that on Saturday, April 8, 2023, in District 4, there is a community clean-up day scheduled from 9:00 a.m. to 11:00 a.m. at 10331 Stanford Avenue at the Garden Grove Unified School District Offices. On Saturday, April 1st is a compost giveaway at the Garden Grove Municipal Services Center, 13802 Newhope Street, from 8:00 a.m. through 10:30 a.m. Compost will be limited to 60 gallons per Garden Grove resident. Staff will be providing a full report on the City Council retreat highlighting the City Council priorities. She thanked the City Council for a wonderful and warm reception welcoming her as the City's new City Manager, and she expressed her appreciation for the members of the community who attended.

Mayor Jones adjourned the meeting in memory of Nguyen Dinh, a Garden Grove Community Services employee, who tragically passed away at the young age of 20 as a result of an automobile accident.
