PUBLIC HEARING - CONSIDERATION OF AN ORDINANCE UPDATING THE CITY'S LAND USE REGULATIONS PERTAINING TO CANNABIS DISPENSARIES, DELIVERY, AND CULTIVATION; AND CONFIRMING UNLISTED USES ARE PROHIBITED (F: 115.A-015-2015)

(As approved earlier in the meeting: It was moved by Council Member Phan, seconded by Council Member Jones and carried by a 5-0 vote that full reading of ordinances listed be waived.)

Acting City Attorney Sandoval reported on the Medical Marijuana Regulatory and Safety Act ("Act") as it compares to the City's current ordinance banning medical marijuana dispensaries in the city. The City's current ordinance does not directly address cultivation of marijuana. Pursuant to the Act, if the City wants to preserve its right to prohibit the delivery and/or cultivation of medical marijuana it must have an ordinance expressly stating so. If the City does not have a land use ordinance in place clearly regulating or prohibiting cultivation by March 1, 2016, the State will automatically become the sole licensing authority for individuals or entities seeking to cultivate marijuana in the city. The proposed ordinance would preserve the status quo and prevent State preemption regarding the cultivation and delivery of marijuana in Garden Grove.

Following Mr. Sandoval's report, the City Council discussed the necessity of this ordinance, as well as the City's history on medical marijuana dispensaries.

Mayor Nguyen declared the Public Hearing open and asked if anyone wished to address the City Council on the matter.

There being no further response from the audience, the Public Hearing was declared closed.

City Council discussed recent legislation amending the Act eliminating this preemptive aspect of the Act. However, it may not be signed by the Governor in time for the March 1, 2016, deadline. Should the legislation be signed prior to the January 26, 2016, City Council meeting, there would be no need for this ordinance and the City Council could vote against the ordinance. The purpose of the proposed ordinance is to keep local control over the delivery and/or cultivation of medical marijuana.

It was moved by Council Member Bui, seconded by Council Member Phan that:

Ordinance No. 2863 entitled: An Ordinance of the City Council of the City of Garden Grove approving Amendment No. A-015-2015 amending Title 9 of the Garden Grove Municipal Code to update the City's Land Use Regulations pertaining

to cannabis dispensaries, delivery, and cultivation, and to confirm that uses not specifically identified in a zoning district are prohibited in that district, be passed to second reading.

Following staff's presentation, it was moved by Council Member Phan, seconded by Council Member Beard that:

A contract to provide on-call civil engineering plan checking and construction inspection services, in the amount not to exceed \$500,000 for three years, with an option for two additional two year extensions, be awarded to Engineering Resources of Southern California, Inc.;

The City Manager be authorized to execute the agreement on behalf of the City and to make minor modifications as appropriate; and

The City Manager be authorized to enter into the extensions for two additional two year terms should a funding balance remain.

DISCUSSION REGARDING THE REPEAL OF THE MEDICAL MARIJUANA BAN, AS REQUESTED BY MAYOR NGUYEN (F: 50.2)(XR: 115.A-015-2015)

In light of the discussion during the Public Hearing regarding cannabis dispensaries, cultivation, and delivery ordinance, and in response to the Governor signing the Medical Marijuana Regulatory and Safety Act, Mayor Nguyen proposed that staff be directed to return with information on changing the direction on banning medical marijuana within the city.

After City Council discussion, it was the consensus of the City Council that staff begin developing regulations and the process to allow medical marijuana dispensaries within the city. Information requested should include providing options on how to tax, comprehensive timeline, land use, community meetings, negative impacts, economic exposure, legal fees, Planning Commission process, ballot measure to the voters if necessary, and other information deemed necessary by staff.

Mayor Nguyen announced that he would be conducting open door meetings on a first come first serve basis.

Council Member Bui requested that an item be placed on the next agenda for discussion: Provision that non-profit organizations making annual funding requests from the City, that each year the request would be less than before, ultimately eliminating its dependence on the City for funding. It was moved by Council Member Beard, seconded by Mayor Nguyen that an action item be placed on the next City Council agenda regarding Commissioner qualifications, including residency and registered voter requirements, Municipal Code clarification, ambiguities in the application process, and the removal of Commissioners.
