Mayor Jones noted that in response to Propositions 47, 57, and Assembly Bill 109, the League of California Cities is asking for cities to support a proposed Ballot Measure titled: Reducing Crime and Keeping California Safe Act of 2018.

Council Member Beard commented on the recent City Council Special Meeting that was held on Friday, March 23, 2018; noting that the meeting was very productive.

Council Member O'Neill commended the Police and Fire Departments for their work in saving lives. He noted that he and Council Member K. Nguyen both attended the Garden Grove Chamber of Commerce's 112th gala event where the Garden Grove Man and Woman of the Year, Scott Weimer of the Downtown Business Association, and Gayle Knight of HOPE were recognized for their work in the community. He noted the upcoming 50's themed dinner and dance will be held by the Women's Civic Club of Garden Grove on June 23, 2018, as a fundraiser to help disabled veterans in Garden Grove.

Council Member T. Nguyen thanked the Police Officers who work to keep us safe, and expressed appreciation for City staff. She commented that the City Council Special Meeting was very informative, noting the financial challenges the City will face in the future.

Council Member Klopfenstein commented on meeting with a "Mom" from District 5 named Claire who spoke with her on several issues. She expressed appreciation for Claire's commitment to her family and her neighborhood, as well as the people she meets who have a passion for Garden Grove. She reminded everyone to be aware of standing water around their home as there is increased mosquito activity throughout Orange County that carry the West Nile Virus and pose a health risk to pets. Council Member Bui thanked the Police for their work in saving lives noting that over the years he has witnessed numerous officers recognized for their courage and tonight he was very touched to hear the Police Chief give an account of the officers who saved young children. He commented on his surprise that a former pro baseball pitcher resides in Garden Grove and will be turning 100 in July.

City Manager Stiles noted that Chuck Stevens is the soon to be centenarian former baseball professional. He concluded that the International Council of Shopping Centers event in Las Vegas is scheduled from May 21, through May 23, 2018, and that staff will be bringing an agenda item for the City Council to consider at the next meeting for three City Council Members to attend the event.

Mayor Jones thanked Council Member Klopfenstein for commenting on meeting with Claire, noting that their purpose as Council Members is to serve the people, and he
