<u>DISCUSSION AND CONSIDERATION OF THE ORANGE COUNTY FIRE SERVICES</u>
<u>PROPOSAL AND RELATED ANALYSIS AS REQUESTED BY CITY MANAGER STILES</u>
(F: 61.1)

City Manager Stiles stated that the purpose of bringing this matter before the City Council is to provide information and to open discussion on the next steps. Since the Study Session that was held August 28, 2018, there was a meeting held with the City staff, Fire Association representatives and OCFA representatives to discuss any issues, which included Council Members Bui, K. Nguyen, and Klopfenstein. He

announced that tonight's PowerPoint presentations on the analysis are provided by the Finance Department staff, Fire Chief Schultz, and Eric Thorson representing the Firefighters Association Local 2005.

Following City Council discussion, including questions for representatives speaking on behalf of the Orange County Fire Authority, it was moved by Council Member Bui, seconded by Council Member O'Neill that:

Staff be directed to meet and collaboratively work on providing a comprehensive spreadsheet to include variable scenarios to determine risk assessments and to bring this matter back as a discussion and an action item.

Council Member Beard expressed appreciation to the Fire Department for their response to an emergency call from his home.

Council Member O'Neill thanked the Fire Department for their response to a recent fire incident in District 2. He encouraged everyone to attend the Christmas Boutique at the Woman's Civic Organization on October 27, 2018.

Council Member T. Nguyen thanked staff for their work during the Mid-Autumn Children's Festival at the Atlantis Play Center; and she wished her son a happy birthday.

Council Member K. Nguyen thanked the City staff, the Fire Association, and OCFA for their patience necessary to work through the process of evaluating fire services. She noted that the approved budget reductions have cut out fun things that benefit the residents; however, she appreciates the City staff for their dedication and commitment to Garden Grove.

Council Member Klopfenstein expressed her appreciation for the Mid-Autumn Children's Festival commenting that it was a beautiful event. She noted that for clarification to the residents, Vector Control will not spray for mosquitoes on private property; however, a Vector Control technician can be scheduled to inspect your property for mosquitoes and provide tips and techniques for abating mosquitoes.

Council Member Bui expressed appreciation for all of the work done by staff and OCFA on the OCFA proposal and review and analysis. He commented that this is an

important decision, and asked that his apology be accepted if he offended anyone with hard questions.

Mayor Jones noted that community icon, Jack Wallin, passed away September 21st, and expressed his appreciation for Jack Wallin's contributions to Garden Grove, including serving as a board member on the Strawberry Festival Association for the past 60 years. Jack Wallin earned the title of grand marshal of the Garden Grove Strawberry Festival in 2008 and in 2018; he was Garden Grove Chamber Man of the Year and Cypress College Americana Citizen of the Year; and he helped design and build the Atlantis Play Center. Mr. Wallin is survived by his wife Marge, five children, ten grandchildren, and one great-grandchild. Mayor Jones expressed his sincere condolences to Jack Wallin's family.
