Council Member Brietigam requested that information be provided on the efforts made by the City staff to address short-term rentals in the City.

Mayor Pro Tem O'Neill reminded everyone to take safety precautions during the holiday season, and he thanked the Mayor and City Council for selecting him to serve as Mayor Pro Tem.

Council Member T. Nguyen congratulated Mayor Pro Tem O'Neill, and she wished her husband a happy 15 year anniversary of their marriage.

Council Member K. Nguyen announced the upcoming Winter in the Grove on Thursday, OC Autism event, and the Garden Grove Chamber of Commerce Holiday Mixer. She encouraged residents to pay attention to announcements made by the City on the website and social media.
