MATTERS FROM THE MAYOR, CITY COUNCIL MEMBERS, AND CITY MANAGER

Council Member Klopfenstein stated that in response to a viral video of a Garden Grove resident confronting a neighbor and making racist and incendiary comments, she posted on her Facebook page a statement condemning racist rants of any kind. She noted that Police Officers responded, and the victim of the racial slurs did not press charges. She stated that she values and celebrates differences and diversity, and that the racist resident does not represent the true spirit of Garden Grove. She thanked the City's Code Enforcement Division for their responsiveness on her request to address overgrown weeds on vacant lots.

Council Member D. Nguyen wished Council Member Brietigam a happy birthday.

Council Member Brietigam wished a happy birthday to his mother-in-law Patricia and to his son.

Mayor Pro Tem O'Neill wished Council Member Brietigam a happy birthday. He noted the issues with dumping and weeds in the right-of-way properties that are not included in the bike and pedestrian trail, and that there are multiple agencies and private owners who are responsible for maintenance. He assured that the City has and adheres to a legal process for addressing these issues on an ongoing basis.

Council Member K. Nguyen echoed Council Member Klopfenstein's condemnation of racist rants. She also thanked staff and the Police Department with assisting her with a particular resident's issue.

City Manager Stiles noted that it was announced that we are now in the Red Tier for COVID, and stated he recently had a conversation with a church pastor who was happy to learn that in addition to holding outdoor services, indoor services will be allowed at 25 percent capacity. He encouraged residents to visit https://covid19.ca.gov/safer-economy/ to learn more about what businesses are open.

Mayor Jones commented on his excitement for moving into the Red Tier category, and noted he has been focusing on how we can safely and sensibly reopen businesses as soon as possible. Entering into the Red Tier category allows for churches, restaurants, and cinemas to reopen following specific guidelines and allows for 25 percent capacity. He is happy to see that we are keeping our COVID numbers down and that we are heading in the right direction.
