### ADOPTION OF ORDINANCE NO. 11 AMENDING THE DISTRICT'S SOLID WASTE REGULATIONS TO COMPLY WITH SB 1383 ORGANICS RECYCLING MANDATES (F: S-127.2)

Following general counsel introduction and member discussion there was a request for information on the using decomposable bags, and a question on the enforcement of SB 1383. General Counsel noted that the City will be required to enforce the law, as a fine of \$10,000 per day could be imposed if found noncompliant. Following further member discussion, it was moved by Member K. Nguyen, seconded by Member Brietigam that:

Ordinance No. 11 entitled: An Ordinance of the Board of Directors of the Garden Grove Sanitary District amending Chapters 1.20, 5.10, 6.10, and adding Chapter 6.15 of the Garden Grove Sanitary District Code of Regulations pertaining to solid waste regulations and administrative citations to comply with SB 1383 Organics Recycling Regulations, be adopted.
